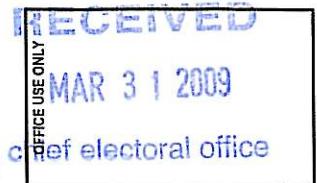

AUDITOR'S REPORT


To the Board of Directors of the
Alberta Party Political Association

I have audited the balance sheet of the Alberta Party Political Association as at December 31, 2008, and the statements of revenues, expenditures, accumulated surplus and changes in cash flows for the year then ended. These financial statements are the responsibility of the Association's management. My responsibility is to express an opinion on these financial statements based on my audit.

I conducted my audit in accordance with generally accepted auditing standards. Those standards require that I plan and perform an audit to obtain reasonable assurance whether the financial statements are free of any material misstatement. An audit includes examining, on a test basis, evidence supporting the amounts and disclosures in the financial statements. An audit can also include assessing the accounting principles used and estimates made by management, as well as evaluating the overall financial statement presentation.

In common with many not-for-profit enterprises, the Association derives most of its revenue from donations and fund raising, the completeness of which is not susceptible to satisfactory audit verification. Accordingly, my verification of revenue was limited to a review of amounts as recorded in the records of the Association, and I was not able to determine whether any adjustments might be necessary to donations and other revenues, excess of expenditures over revenues, assets and equity.

In my opinion, except for the effect of adjustments, if any, which might have been determined to be necessary, as per referred to above, these financial statements present fairly, in all material respects, the financial position of the Association as at December 31, 2008, and the results of its operations and the changes in cash flows for the year then ended in accordance with generally accepted accounting principles.
