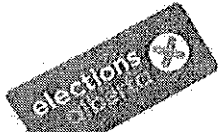

In our opinion, except for the effects of the qualification in the previous paragraph, the financial statements present fairly, in all material respects, the financial position of Wildrose Alliance Political Association as at December 31, 2010 and the results of its operations and its cash flows for the year then ended in accordance with generally accepted accounting standards .




**1. Nature of operations**

Wildrose Alliance Political Association ("the Association") is a registered as a political party in Alberta. The Association is a non-profit organization and as such is exempt from income tax.

**2. Significant accounting policies**

The Association follows accounting principles generally accepted in Canada in preparing its financial statements. The significant accounting policies used are as follows:

**(a) Measurement uncertainty**

The preparation of financial statements in accordance with Canadian generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities at the date of the financial statements, and the reported amounts of revenues and expenses during the period. Actual results may differ from management's estimates as additional information becomes available in the future.

**(b) Property and equipment**

Property and equipment are recorded at cost. The Association provides for amortization using the following methods at rates designed to amortize the cost of the property and equipment over their estimated useful lives. The annual amortization rates and methods are as follows:

Computer software	50% Declining balance

Amortization of leasehold improvements is recorded over the remaining term of the lease plus the first renewal option.

**(c) Contributed Materials and Services**

The organization receives contributions of materials and volunteer services each year in carrying out its activities. Contributed materials and services are recorded in the financial statements to the extent that the fair value is reasonably determinable.

2. **Significant accounting policies, continued**

(d) **Revenue recognition**

The Association follows the deferral method of accounting for contributions. Restricted contributions are recognized as revenue in the year in which the related expenditures are incurred. Unrestricted contributions are recognized as revenue when received or receivable when the amount to be received can be reasonably estimated and collection is reasonably assured.

Membership revenue, including amounts for membership periods of greater than one year, is recognized when payment is received or receivable.

Fundraising and investment revenue are recognized when earned.

Transfer revenue are recognized in the period in which the transfer occurs.

(e) **Pledges**

Pledges receivable are not recorded in the Association's financial statements, as there is no assurance that they will ultimately be collected. Pledges are recorded in the financial statements when they are received.

(f) **Financial instruments**

The Association financial instruments consist of cash, accounts receivable, accounts payable and accrued liabilities. Unless otherwise noted, it is management's opinion that the Association is not exposed to significant interest, currency or credit risks arising from these financial instruments.

The Association has designated its cash as held-for-trading which is measured at fair value. Accounts receivable are designated as loans and receivables, which are measured at amortized cost. Accounts payable and accrued liabilities are designated as other financial liabilities. The Association had neither available for sale, nor held to maturity instruments during the year ended December 31, 2010.

**(g) Capital disclosures**

The Association defines its capital as the amounts included in its net asset balances.

The Association's objective when managing its capital is to safeguard the Society's ability to continue as a going concern so that it can continue to provide the appropriate level of benefits to its stakeholders.

The Association sets the amount of net asset balances in proportion to risk, manages the net asset structure and makes adjustments to it in light of changes in economic conditions and the risk characteristics of the underlying assets.

The Association expects its current capital resources will be sufficient to meet its objectives through its current operating period.
