



This candidate and chief financial officer (CFO) failed to eliminate a campaign deficit incurred during the 2015 Provincial General Election as required by section 43 of the *Election Finances and Contributions Disclosure Act* (EFCDA).

In accordance with section 44(1) of the EFCDA, the Chief Electoral Officer transmitted a report to the Speaker of the Legislative Assembly on May 4, 2016 containing the names of the candidate and CFO. The report was tabled before the Legislative Assembly on May 9, 2016.

The candidate and CFO are prohibited from being nominated as a candidate or acting in the capacity of a CFO for a period of 8 years from the date on which the Speaker tabled the report; that is, until May 9, 2024.
